

VAT refund is made by the Global Blue tax rebate (<http://www.globalblue.com/>) and is subject to certain conditions.

1) Conditions to benefit from the tax refund

You must be a resident of a State outside the European Union on the date of purchase, stayed in France for less than 6 months and be 16 years of age or older. Residents of a Member State of the European Union, the Overseas Departments and Monaco will not be entitled to the tax refund. Students, trainees and immigrant workers living in France are also excluded, even if they return permanently to their country of origin. To benefit from the tax, the amount of your purchases, in the same day, must be strictly higher than 175 € TTC (excluding postage and services). The goods purchased must be for personal use.

2) Steps to benefit from the tax refund

In order to obtain the refund of the VAT, Snowleader issues (via the company Global Blue tax refund) an export note that will be sent to you by mail, to your address of residence in France. This export note must be stamped by customs and returned to Global Blue using the pre-stamped envelope provided to trigger the VAT refund process. You will have to place an order of more than 175 € TTC on the site Snowleader.com taking care to fill in your address of residence outside the European Union as your address of invoice. The delivery address must, for its part, be a French address. Once the order has been validated, please send us the following by e-mail to contact@snowleader.com:

- Your order number, your name and your first name
- A two-sided copy of your valid ID or passport
- A copy of your residence permit outside the European Union if your residence address is not on the identity document
- A proof of residence abroad
- A bank account statement (BIC/SWIFT + IBAN)

ATTENTION: The invoice must be issued at the time of the purchase, please send us these documents by mail at the latest on the day of the payment of your order.

3) Refund

You have 3 months from the date of invoice of the order to present yourself in customs with the export note, the invoice and the goods. Once the customs clearance note has been issued (customs checked on the PABLO terminals), Global Blue will refund the VAT within 3 weeks after receipt of the original validated note or immediately at the cash desk. The amount of the refund depends on the VAT rate.

VAT rate	Refund rate	Method of refund
20%	13,00%	By CB, Check or Wire Transfer
20%	10,80%	Cash
5,5%	3,00%	All
10%	6,00%	All

For example, for a purchase of 176 € VAT incl. 20% VAT, the VAT reimbursed by Global Blue will be:

- 22,88 € for a refund by CB, check or bank transfer
- 19 € for a cash refund
